PROJECT DESCRIPTION

The Franklin County Engineer's Office invites you to share your thoughts regarding our upcoming project in your area. We are widening 1.30 miles of Cassady Avenue between Plaza Properties Boulevard and Agler Road, constructing a 10' asphalt shared-use path and 5' concrete sidewalk. The intersection with Agler Road will also be reconstructed to provide a Northbound right-turn lane and Westbound right-turn lane. The project will also include storm sewer replacement, signal modifications, and mid-block pedestrian crossings. Details about the project are below, and a few questions for you to answer are on the second page.

RIGHT-OF-WAY ACQUISITION

Permanent and temporary right-of-way will be needed for this project. If right-of-way acquisition is necessary from your property, a real estate representative will contact you directly at a later date to discuss the right-of-way needs, the acquisition process, and your rights under that process.

Cassady Avenue Widening

- Two 10' through lanes of traffic
- One 10' center lane (TWLTL=Two-Way Left-Turn Lane)
- 10' shared-use path along the west side of Cassady Avenue
- 5' sidewalk on the east side of Cassady Avenue
- Signal improvements and updated striping at Agler Road.
- Culvert replacements at the 2 stream crossings along the corridor
- Addition of NB RT and LT and WB RT turn lanes at the Agler Road intersection

Construction Cost Estimate: \$12.3 million

Maintenance of Traffic during Construction

- One-way southbound traffic maintained for all phases
- Detour utilizes Johnstown Road, Stelzer Road, and Agler Road
- Access to drives and intersections maintained at all times
- Maintenance of traffic shall be active for approximately 9 months

• Construction Complete: 04/2029
