The Franklin County Engineer's Office invites you to share your thoughts regarding our upcoming project in your area. We are rehabilitating the bridge on Cooper Road Over Noble Run. #### Existing Bridge

- Built in 1970
- Condition Rating: 6  
(scale: 9 = best, 0 = worst)
- Two lanes of traffic, 12-foot wide, 6-foot shoulders

#### Rehabilitated Bridge

- New superstructure (beams)
- Two lanes of traffic, 11-foot wide
- Shoulders will be 4-foot wide & 2 foot wide
- Sidewalk on the east side will be 7' wide

**Construction Cost Estimate:** \$875,812

#### Schedule

- Design Complete: Spring 2026
- Construction: Summer-Fall 2027

#### Maintenance of Traffic during Construction

- Construction will be completed via a full road closure. The anticipated closure duration is 90 days, starting in Summer 2027. This would impact vehicular traffic.
