# DUBLIN ROAD IMPROVEMENTS

**FRA-CR10-7.14 (PID 119688)**

## Project Description

The Franklin County Engineer's Office, along with the cities of Hilliard, Columbus, and Dublin, with support from the Ohio Department of Transportation (ODOT), are planning to install an approximately 4.25 mile shared use path along Dublin Road from Quarry Trails Metro Park to Limestone Ridge Drive. The project will also include modifications to existing bridges, lighting improvements, and the installation of enhanced crossings to provide access to neighborhoods on the opposite side of Dublin Road. The project is needed to provide safe pedestrian and bicycle access along the corridor.

## Schedule

- Right-of-Way Acquisition - Summer 2026
- Utility Relocation - Summer 2027
- Begin Construction - Spring 2028
- End Construction - Spring 2029

Design will continue to be refined using the results of current study efforts and public input. Permanent and temporary (just for construction) right-of-way will likely be needed for the project. If right-of-way acquisition is necessary from your property, a real estate representative will contact you directly at a later date to discuss the right-of-way needs, the acquisition process, and your rights under that process.

## Traffic Impacts

The project partners are working to minimize delays and impacts to the surrounding communities, businesses, and residents as much as possible. For the majority of the project, two lanes of traffic will be maintained in each direction although some short-term lane reductions may be needed.

## Funding

It is estimated that the total project will cost approximately \$13 million, including design, right-of-way acquisition, and construction costs. This estimate will be refined as project development continues.

The project has received grant funding from both federal and state sources including MORPC's Attributable Funding for Transportation and COTA's LinkUS Transit Supportive Infrastructure funds.

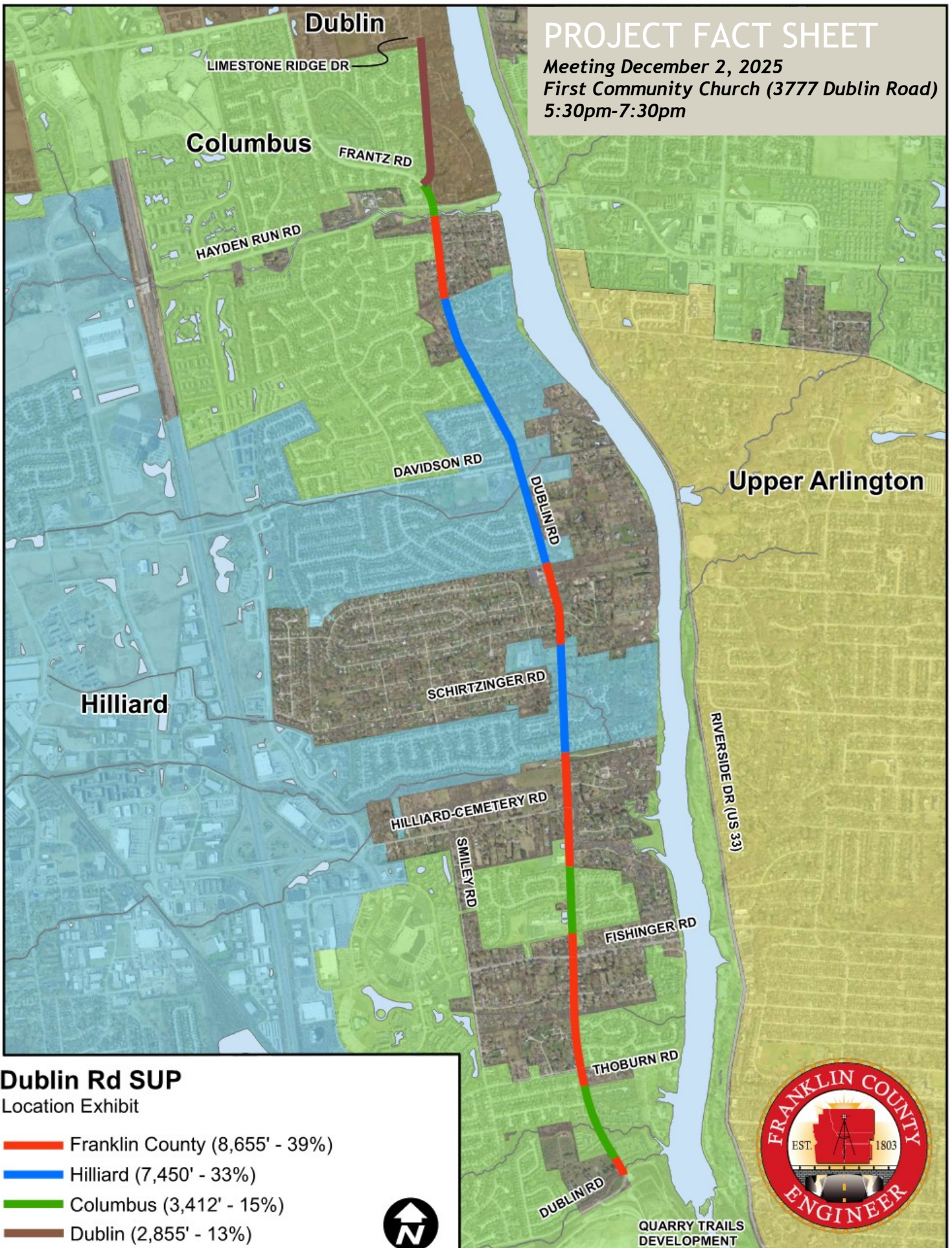
