- Reconfigure the current deck geometry to allow for the addition of a shared-use-path(SUP) along the southern edge of the bridge.
- Substructure reconfiguration
- New concrete deck overlay.
- Four 11'-wide lanes of traffic, 5' sidewalk, 4' northern &
 2' southern shoulders, 12' SUP
- Anticipated Post Rehab Condition Rating: 8
